STUDY PROGRAMME: **BIOPSYCHOLOGY**

TYPE OF STUDY PROGRAMME: MASTER'S, SECOND CYCLE

DURATION: 2 YEARS, 120 ECTS

MODE OF STUDY: full-time study

PLACE OF STUDY: Koper, Izola partly

ADMISSION REQUIREMENTS

Admission to the first year of study shall be granted to the candidates who have completed:

- a) a first cycle study programme in the study field of biopsychology or psychology;
- b) a first cycle study programme in other study fields, provided that they have also completed the study obligations (up to 60 ECTS credit points) deemed essential for continuing their studies. Candidates can complete additional study obligations during their undergraduate studies, in training programmes, or by passing the exams prior to their enrolment in the master's study programme. Individual applications shall be considered by the Faculty Commission of Academic and Student Affairs;
- c) an equivalent education abroad and have been, in the process of recognition of their qualification and in accordance with Assessment and Recognition of Education Act, legally granted the right to continue their studies in the study programme.

IN CASE OF ENROLMENT LIMITATION the candidates are selected according to average grade obtained in the undergraduate studies (one of their academic requirements is also the Final Project Paper completed during their undergraduate studies).

Study programme is offered in Slovene and English language.

ADMISSION REQUIREMENTS

Admission to the first year of study shall be granted to the candidates who have completed:

- a) a first cycle study programme in any mathematical study field;
- b) a first cycle study programme in other professional fields, provided that they have, prior to enrolment, completed all study obligations that are deemed essential for the continuation of studies in the master's study programme in Mathematics and accumulated at least 30 ECTS credits. The candidates may fulfil study obligations during their first-cycle studies, under training programmes, or by taking examinations prior to enrolment in the study programme Mathematical Sciences;
- c) an equivalent education abroad and have been, in the process of recognition of their qualification and in accordance with Assessment and Recognition of Education Act, legally granted the right to continue their studies in the study programme.

Individual application for enrolment of the candidates referred to in the second indent of the first paragraph shall be considered by the competent Faculty's Commission. The candidate shall complete additional study obligations before enrolling in the master's study programme.

MODE OF STUDY: full-time study

PLACE OF STUDY: Koper

ADMISSION REQUIREMENTS

Admission to the first year of study shall be granted to the candidates who have completed:

- a) a first-cycle study programme in the field of mathematics in economics and finance, financial mathematics, or mathematics, *or*
- b) a professional higher education study programme (adopted before 11 June 2004) in the field of mathematics in economics and finance, financial mathematics, or mathematics, *or*
- c) a study programme from any other field of expertise, equivalent in time and scope to the programmes under a) or b); in this case the applicant is required to fulfil additional academic requirements, the content and extent of which depend on the previously completed study programme. Additional academic requirements shall be determined by the relevant committee of UP FAMNIT. Applicants may fulfil these additional academic requirements during their undergraduate studies, in training programmes, or by taking examinations prior to enrolment;
- d) an equivalent education abroad and have been, in the process of recognition of their qualification and in accordance with Assessment and Recognition of Education Act, legally granted the right to continue their studies in the study programme.

- a first cycle study programme in other professional fields that are not included in paragraph a), provided that a candidate has completed the study obligations in an amount from 10 to 60 ECTS credits (from the first cycle study programmes Mathematics and Computer Science UP FAMNIT) relevant for further study prior to enrolment. The candidate may fulfil study obligations during their first-cycle studies, under training programmes, or by taking examinations prior to enrolment in the study programme Data Science. Upon examination of the candidate's previous study programme, the competent Faculty Commission shall define each candidate's additional academic requirements on a case-by-case basis. The candidate shall complete additional study obligations before enrolling in the master's study programme;

STUDY PROGRAMME: PSYCHOLOGY

TYPE OF STUDY PROGRAMME: MASTER'S, SECOND CYCLE

DURATION: 2 YEARS, 120 ECTS

MODE OF STUDY: full-time study

PLACE OF STUDY: Koper

ADMISSION REQUIREMENTS

Admission to the first year of study shall be granted to the candidates who have completed:

- a) a first cycle study programme in the field of psychology or biopsychology that complies with the requirements of the EuroPsy Certificate, earning at least 180 ECTS credit points;
- b) a first cycle study programme of at least 180 ECTS credit points from the field of biopsychology, having also completed academic requirements of 10 to 42 ECTS credit points that are deemed essential for the continuation of their studies, namely from the list of courses in the following subdisciplines: educational psychology, work and organizational psychology, developmental psychology, clinical psychology, research methods, differential psychology and (bio)psychology of motivation and emotions. Upon examination of the candidate's previous study programme the competent Faculty Commission shall define each candidate's additional academic requirements on a case-by-case basis. The additional study requirements may be completed during the candidate's undergraduate studies, in training programmes or by passing exams (courses) before enrolling in the master's study programme;
- c) another first cycle study programme, provided that the programme covered at least 120 ECTS credit points in topics from the field of psychology and that prior to enrolment the candidate has completed additional academic requirements essential for further studies to the total of 30 to 60 ECTS credit points. Suitability of the completed study programme, and consequently the possibility of enrolment in the present programme, is decided upon by the competent Faculty Commission, which reviews the submitted undergraduate study programme the candidate has completed and any other evidence of the proficiencies the candidate has acquired. Having established that the completed study programme potentially allows the candidate to enrol in the master's study programme, the Commission then determines the additional academic requirements the candidate must complete, depending on the disciplinary field of the candidate's previous studies. Candidates may complete these additional academic requirements during their undergraduate studies, in training programmes, or by taking exams (courses) before enrolling in the master's study programme;

- d) an equivalent education abroad and have been, in the process of recognition of their qualification and in accordance with Assessment and Recognition of Education Act, legally granted the right to continue their studies in the study programme Psychology.

IN CASE OF ENROLMENT LIMITATION the candidates are selected according to:

- success in the selection exam (30 %),
- the average grade obtained in their undergraduate study programme (70 %). All study obligations from the undergraduate study programme, including the Final Project Paper, is included in the average grade. The grade-point average of applicants who have completed a study programme under b) or c) of the conditions for admission to the programme also includes the grades of their additional academic requirements (bridge exams).

The method of conducting the selection exam will be determined by the Commission UP FAMNIT.

ADMISSION REQUIREMENTS

Admission to the first year of study shall be granted to the candidates who have completed:

- a) a first cycle study programme in relevant professional fields and achieved at least 180 ECTS credit points;
- b) a study programme leading to a professional higher education degree or a study programme leading to a university degree in appropriate professional fields (pre-reform study programmes, adopted before 11 June 2004);
- c) an equivalent education abroad and have been, in the process of recognition of their qualification and in accordance with Assessment and Recognition of Education Act, legally granted the right to continue their studies in the study programme.

Undergraduate study programmes considered as appropriate professional fields for enrolment in the master's study programme are those pursuing the following study fields: *Computer Science, Computer Science and Mathematics, Mathematics, Electrical Engineering, Bioinformatics.*

Candidates having completed study programmes from other professional fields equivalent in their scope and duration to the study programmes in the above paragraph must fulfil additional study obligations, the contents and scope of which depend on the previously completed undergraduate study programmes. Additional study obligations comprise courses determined from the undergraduate study programme Computer Science (UP FAMNIT) in the amount from 10 to 60 ECTS credit points.

An individual application for enrolment of the candidates referred to in the third indent shall be considered by the competent Faculty Commission. The candidate shall complete additional study obligations before enrolling in the master's study programme.

In this case, the candidate has to pass study obligations that are fundamental for enrolment, in an amount up to 30 ECTS credit points. - c) a first-cycle study programme accumulating at least 180 ECTS credit points in other study fields that are not included in paragraphs a) and b). The candidate has to pass study obligations that are fundamental for enrolment, in an amount up to 60 ECTS credit points. Upon examination of the candidate's previous study programme, the competent Faculty Commission shall define each candidate's additional academic requirements on a case-by-case basis;
- d) an equivalent education abroad and have been, in the process of recognition of their qualification and in accordance with Assessment and Recognition of Education Act, legally granted the right to continue their studies in the study programme.

PROCEDURES FOR APPLICATION FOR ENROLMENT AND APPLICATION PERIODS ARE PUBLISHED IN THE DOCUMENT »**PROCEDURES AND APPLICATION PERIODS FOR SUBMITTING THE APPLICATION FOR ENROLMENT INTO MASTER’S DEGREE STUDY PROGRAMMES OF THE UNIVERSITY OF PRIMORSKA IN THE ACADEMIC YEAR 2026/2027**«.

Candidates who intend to study in the master’s study programmes at UP FAMNIT can apply for enrolment, regardless of whether they have already obtained a diploma at the time of submitting the application. Diploma is not a prerequisite for application. Candidates must submit the required evidence of fulfilment of the enrolment no later than the deadlines specified in »Common provisions«.

Candidates are required to submit the evidence of fulfilment of the enrolment conditions and all supporting documents electronically via the eVŠ web portal.

Scanned documents or photographs of original certificates and other required documents are considered as proof that the enrolment conditions in the application and admission procedure have been met.

DOCUMENTS REQUIRED FOR THE ADMISSION PROCEDURE (EVIDENCE OF FULFILMENT OF THE ENROLMENT CONDITIONS)

For enrolment in the first year candidate must submit:

- a. an e-copy or photograph of the Diploma certificate – mandatory document,
- b. an e-copy or photograph of the Transcript of records or Diploma supplement (the average grade of the previous study shall be evident) – mandatory document.

For enrolment in the first year (parallel studies) candidate must submit:

- a. an e-copy or photograph of the Transcript of records - the average grade of the study shall be evident – mandatory document,
- b. an e-copy or photograph of the approval of the (parent) higher education institution – mandatory document.

For enrolment in the second year (according to Criteria for transferring between study programmes) – if candidate has already obtained a diploma - candidate must submit:

- a. an e-copy or photograph of the Diploma certificate – mandatory document,
- b. an e-copy or photograph of the Transcript of records or Diploma supplement (the average grade of the previous study shall be evident) – mandatory document;
- c. e-copies or photographs of syllabuses (approved by the (parent) higher education institution) – mandatory document.

For enrolment in the second year (according to Criteria for transferring between study programmes) – if candidate is a student - candidate must submit:

- a. an e-copy or photograph of the Transcript of records - the fulfilment of the conditions for advancement in the previous study shall be evident – mandatory document;
- b. e- copies or photographs of syllabuses (approved by the (parent) higher education institution) – mandatory document.

INFORMATION ABOUT RECOGNITION OF FOREIGN EDUCATION

Candidates who have completed comparable studies abroad and who (in accordance with the Assessment and Recognition of Education Act in Slovenia) have been granted the right to continue their studies in an individual study programme in the process of recognizing foreign education, may also enrol in master study programme.

Candidate who has completed education abroad and has already obtained a **decision of recognition of foreign education** proves fulfilment of the conditions for enrolment in the first or higher year of study by submitting a decision of recognition.

Candidate with a foreign certificate must submit an electronic application for enrolment via the eVŠ web portal: <https://portal.evs.gov.si/prijava/?lang=en>

For candidate with a foreign certificate in education, who **does not have a decision on recognition of education yet**, the application for enrolment is also **considered as an application for the recognition of foreign education**. Candidate must fill out the section in the application regarding the recognition of foreign education and submit all supporting documents stated in the Call for enrolment. Candidates comply with the deadlines for the submission of supporting documents for admission and enrolment conditions that apply to the admission and selection procedure described in the document **»PROCEDURES AND APPLICATION PERIODS FOR SUBMITTING THE APPLICATION FOR ENROLMENT INTO MASTER'S DEGREE STUDY PROGRAMMES OF THE UNIVERSITY OF PRIMORSKA IN THE ACADEMIC YEAR 2026/2027«**.

Candidates are required to submit the evidence of fulfilment of the enrolment conditions and all supporting documents electronically via the eVŠ web portal.

Scanned documents or photographs of original certificates and other required documents are considered as proof that the enrolment conditions in the application and admission procedure have been met.

DOCUMENTS REQUIRED FOR ADMISSION PROCEDURE (EVIDENCE OF FULFILMENT OF THE ENROLMENT CONDITIONS)

Candidate must submit:

- a. an e-copy or photograph of the Diploma certificate – mandatory document,

The authenticity of a copy of the diploma certificate will be checked by the Faculty at the issuer of the original document or at the competent authority of the country of origin of the document. If the Faculty is unable to confirm the authenticity of the

document, it will ask the candidate to send the original document/s of completed education abroad, for which they want to be recognized for the purpose of continuing studies in the application-admission procedure, legalized according to regulations and country of origin.

- b. an e-copy or photograph of the translation of the Diploma certificate into Slovene language (a copy of the translation of the Diploma certificate from point a. in Slovene performed by a court translator is sufficient), please consult the authorized persons at the Faculty regarding the need for translations – mandatory document,
- c. an e-copy or photograph of the Transcript of records of previous studies which includes grade point average – mandatory document,
- d. an e-copy or photograph of the translation of Transcript of records into Slovene language (a copy of the translation of the certificate from point c. in Slovene performed by a court translator is sufficient), please consult the authorized persons at the Faculty regarding the need for translations – mandatory document,
- e. Short chronological description of the entire education (stated by the candidate) – mandatory document,
- f. an e-copy or photograph of the candidate’s identity document with their written consent for:
 - a citizen of a Member State of the European Union: an identity card or a passport (the page containing the candidate’s personal information which indicates their first and last name, date and place of birth, and citizenship);
 - a citizen of a country that is not a Member State of the European Union: a passport (the page containing the candidate’s personal information which indicates their first and last name, date and place of birth, and citizenship).

Appendix is not required. If the faculty needs access to an identity document to establish the identity and citizenship of an individual, they will be invited to enable this access. The faculty is obliged to obtain and verify the evidence required for applying for enrolment and recognition of education for the purpose of continuing education, as determined by the regulations governing proof that the enrolment conditions are met, and documentation is to be attached to the application for recognition of education.

The list of required documents for recognition of foreign education may differ according to the state from which the document originates. Candidates are therefore advised to contact the authorised official at the Faculty, which delivers the study programme they are applying.

Before starting to edit the evidence for the recognition of education candidates are advised to inquire at the Faculty. If the Faculty cannot assess on the basis of the submitted documentation it may request the candidate to submit additional evidence.
